0. Informal Description of Work:

NCITS/L2 is the US-TAG for codes and character sets (JTC 1/SC 2) and for internationalization (JTC 1/SC 22/WG 20). Both subjects are essential for the development of internationally usable systems and applications. These are particularly important in today's marketplace with Web access and international electronic commerce.

1. Executive Summary

The number of L2 members is presently 13. We attribute this strong interest to the growing application of Unicode / ISO 10646 by many companies, on the World Wide Web, and the fact that L2 has taken on the responsibility as TAG for SC22/WG20 - Internationalization. L2 works very closely with the Unicode® Consortium - all technical meetings are co-located.

The work on ISO 10646-1 has two aspects at this time. One is the continuing addition of scripts and characters to the Basic Multilingual Plane, the other is the development of an architecture for the additional planes and subsequent allocation of scripts to them. For both projects, the US is contributing substantially.

And finally, the work on internationalization includes contributions to and reviews of draft standards and technical reports, such as the international string ordering standard, the specification of cultural conventions, and internationalization APIs.

L2 conducted a substantial number of ballots in 1998-99 (see below).

L2 meets about 3 times per year, in line with the SC2 meetings. Co-location with the Unicode Technical Committee meetings is economical because most of the members of L2 are also members of the Unicode Consortium. The increased use of electronic mail and Web distribution of documents and ballots makes 3-day meetings feasible. L2 has switched almost totally to electronic document distribution via our web site, including sets of 20 zipped documents for faster downloading. Paper documents are still needed for newly proposed scripts which can rarely be transmitted due to limitations of available fonts.

L2 has consistently voted for minority script projects - the JTC1 requirement for at least 5 supporting countries for new projects would otherwise prevent SC2/WG2 from doing its work.

The distinction between L and M projects is not clear any more, due to the adoption of ISO standards as ANSI. Since this distinction does not provide valuable information, I will not use it in this report.

The BMP is getting full, work has started for architecture and roadmap for additional planes of ISO 10646. Current plan is to assign plane 1 to additional non-ideographic scripts, while planes 2 and 3 will hold ideographic characters. Plane 14 has been designated for identifiers. The next revision of ISO 10646 BMP will be published in 2000.

Because of the large number of characters involved, it is important that the U.S. participates in all meetings of the IRG, the Ideographic Rapporteur Group, where proposals for extensions to the Unified Repertoire and Ordering for ideographic characters and architectural issues are prepared.

L2's good relationship with the Unicode consortium allows us to submit combined proposals for new scripts. L2 and the Consortium make great efforts to ensure that ISO 10646 and the Unicode Standard stay synchronized. Unicode character property tables are being used in internationalization projects such as sorting.

Without proper character set tagging of data, the integrity of data bases is severely endangered.
